2024-2025 Season

The CPFSC Board of Directors and coaches are excited and ready to begin our 29th Season.

Our objective is to ensure your child works hard, gains confidence, builds upon their skill level and more importantly, has fun! October through December, students will work on the curriculum established by the USFSA Learn to Skate/Basic Skills lesson and will be grouped according to their skill level and not necessarily by age. Each class will consist of a warmup period, instructional skills and free skating time. Duration of each is dependent upon each group's level. Students are tested, and when applicable, awarded badges for the skills accomplished and when approved by their coach, progress to the higher level.

The class structure and schedule will change in January. This is when we begin practicing routines that each group will perform in the Season Finale Show on Sunday, February 23, 2025, at 2:00PM with the dress rehearsal on Saturday, February 22nd at 1:00PM – 3:30PM. Please note, your child may have a show practice time during the February schedule on a day and time other than their regular Monday or Saturday. **If you have questions, please don't hesitate to contact Rhonda.**
